Luncheon Talk Wednesday December 7th

Unraveling "Avalon" in the Northern Appalachian Orogen: Are you a Lumper, or a Splitter?

Cameron Bartsch, Saskatchewan Industry and Resources

Abstract

Mapping, U-Pb dating, and petrological studies continue to provide enhanced information about the geology of southern New Brunswick, but have yet to resolve the controversy surrounding the original relationships between the various fault-bounded belts of rocks that comprise that part of the Appalachian Orogen. The Late Neoproterozoic – Early Paleozoic ages of these rocks are consistent with those observed in the type-section of the Avalon terrane in Newfoundland and equivalent rocks on Cape Breton Island and mainland Nova Scotia. The similar ages have resulted in many workers lumping all of these rocks into a broad Avalon Zone (a.k.a. Avalon Composite terrane, Avalonia), much to the chagrin of the splitters in the crowd. Whether or not these rocks were together in the Early Paleozoic has important implications for the timing of the assembly of the Appalachian Orogen in New Brunswick.

Recent examination of the New River belt, a narrow fault-bounded tectonostratigraphic belt containing the westernmost exposures of Neoproterozoic rocks known in southern New Brunswick, suggests that the theory of a unified Avalon Zone by the Late Neoproterozoic may not accurately explain the whole tectonic story. The belt is characterized by two dated (U-Pb zircon) Neoproterozoic igneous units, the ca. 620 Ma Blacks Harbour Granodiorite and the ca. 555 Ma Ragged Falls Igneous Suite. These two units display evidence of having undergone separate deformational histories throughout the Early Paleozoic, supporting data from more outboard terranes which demonstrate that major orogenic processes were active well into the late Paleozoic in southern New Brunswick.
